Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

March 10, 2015

Invocation was given by Reverend Kevin Carroll, Executive Director of Modesto Gospel Mission.

Congressman Jeff Denham gave an update and reported that he will continue to work on infrastructure issues from water storage to fixing our local roads and freeways, including Highway 132 and the 7th Street Bridge. He spoke regarding various issues including the need for a western states bill that will complement the State's water bond, and the need to fix the tax structure so that we can fund the highway bill. He invited the Board, when the County's delegation goes to Washington D.C. later this year, to work with his office to coordinate efforts to push the local agenda forward. He also reported that he is working on obtaining more visas for Assyrians that are being persecuted in the Middle East, and that he will be reaching out to the Board for letters of support regarding this issue.

Vernon Price spoke in support of SB 608, the Right to Rest Act. He noted that there will be a homeless voter registration drive in Turlock on 04/02/2015 from 11:00 a.m. to 2:00 p.m.

Rick Ferroni voiced concerns regarding a nuisance abatement issue on a property on Elm St. in the Salida area. Jami Aggers, Director of Environmental Resources, gave an update to the Board regarding Code Enforcements efforts in addressing this nuisance.

Supervisor O'Brien reported that he was in Washington D.C. last week for the San Joaquin Valley Air Pollution Control District to discuss serious issues with the Environmental Protection Agency (EPA). He noted that we need the cooperation of the EPA, and pressure from our legislators in Washington D.C., to make sure the EPA works with our Air District. Otherwise, there may be serious consequences that will come back to the residents in the eight county Air District basin. He noted that there is a process in April regarding the designation of ozone nonattainment, and that he will report more regarding this issue as the Air District takes action.

CEO Risen reported that over 2,400 pieces of legislation have been introduced at the State Capitol. The County will work with our lobbyist and the state associations to review these proposed bills. He thanked the Board for their support of the Mid-Year Budget this morning.
