Milton O'Haire, Agricultural Commissioner, presented the 2014 Stanislaus County Agricultural Crop Report.

- *B7 Approved Contract # 15-10459 with the California Department of Public Health Services for the continuation of the Immunization Assistance Program for the period of 07/01/2015– 06/30/2017; and, authorized the HSA Managing Director, or her designee, to sign and execute the contract and any subsequent contracts or amendments thereafter – HSA 2015-457
- *B11 Approved the award of a construction contract for the Crisis Stabilization Unit (CSU) Project at 1904 Richland Avenue, Ceres, California to Simile Construction Service, Inc. of Modesto, California for the lump sum amount of \$927,000; authorized the Project Manager to negotiate and sign contracts, work authorizations and purchase orders for professional services necessary for the Project as long as they are within the Project Budget; authorized the Project Manager to negotiate and sign corder Policy, as long as they are within the previously approved Project Budget; authorized the Project Manager to issue a Notice to Proceed upon receipt of proper insurance, bonds and other contractual requirements; and, directed the Auditor-Controller to adjust the budget as detailed in the budget journal form CEO
- *C1 Approved Amendment No. 1 to the Professional Design Services Master Agreement with ENGEO, Inc. in the amount of \$250,000 and extend the agreement for an additional 24 months to expire on 10/21/2017; approved Amendment No. 1 to the Professional Design Services Master Agreement with Wallace-Kuhl & Associates in the amount of \$250,000 and extend the Agreement for an additional 24 months to expire on 10/21/2017; and, authorized the Public Works Director to sign the amendments – PW 2015-459
- *C2 Approved the purchase of one set of four Stertil-KONI ST1085-2FRA mobile column lifts, one SKY250 and components, and one ECOLIFT and components from Stertil-KONI in the amount of \$266,367.15 from Municipal Maintenance Equipment, Inc; and, authorized the Purchasing Agent to issue a purchase order for the equipment using the Houston-Galveston Area Council (HGAC) cooperative purchasing contract PW 2015-460
- *D1 Rescinded a portion of Williamson Act Contract No. 1974-1808, located on Carver Road (APN: 004-075-041), west of the Community of Del Rio; pursuant to Government Code Section 51257, determined that the following seven findings can be made based on the written evidence submitted by the applicant: (a) the new contract would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years except as authorized under the County's implementation of AB 1265; (b) there is no net decrease in the amount of the acreage restricted; in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; (c) at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract or contracts; (f) the lot line adjustment is not

likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the general plan; approved a new contract pursuant to Lot Line Adjustment PLN2014-0126, Girdner; and, authorized the Director of Planning and Community Development to execute a new contract – Planning 2015-461

O'Brien/Monteith unan. ***B10** Approved the final acceptance and completion of the construction of the Sheriff Coroner's Facility Project located at County Center III with Simile Construction Service, Inc. of Modesto, California; approved the final contract with Simile Construction Service, Inc. of Modesto, California as follows: original contract amount \$4,074,000 plus change orders, \$387,562, for a total contract amount of \$4,461,562; and, authorized the Project Manager, on behalf of the Board of Supervisors as the Awarding Authority, to sign completion documents, record the Notice of Completion, release retention less withholdings, and process all remaining close out activities for the contract and Sheriff Coroner's Facility project – CEO 2015-464

Monteith/Chiesa (3-2)(O'Brien and DeMartini opposed) **B12** Accepted the FY 2015-2016 Mental Health Services Act (MHSA) Plan Update; authorized the use of Stanislaus County's California Housing Finance Agency funds in the amount of \$490,000 in partnership with the City of Modesto and Community Transitional Resources, a local non-profit, for the Permanent Supportive Housing and Community Resource Center Project to be located at 522 East Granger Avenue, Modesto, California; authorized the BHRS Director to direct funds held at the California Housing Finance Agency (CalHFA) for the development of the Granger Avenue Supportive Housing and Community Resource Center Project; and, authorized the BHRS Director to submit a letter to the City of Modesto informing them of the County's intent to authorize the release of CalHFA funds for the Granger Avenue Project – BHRS 2015-465
