Invocation was given by Captain Dwaine Breazeale from The Salvation Army.

Rhonda Allen spoke regarding the problem of homelessness and mental illness in the County. She provided information regarding Laura's Law.

Linda Mayo spoke regarding her experience dealing with a family member with mental illness and in support of Laura's law. She noted that her family member received long term treatment in LA County due to the enactment of Laura's Law.

Josephine Lambert also spoke regarding her experience with a family member with mental illness and encouraged the Board to implement Laura's Law in Stanislaus County.

Supervisor Withrow responded that Rick DeGette, Director of BHRS, is putting together a strategic planning session with all the stakeholders to better understand the pros and cons of Laura's Law. CEO Risen noted that the County is going to hire a consulting firm to assist with this effort.

Robert Bendorf, Community Development Manager of Home Energy Renovation Opportunity (HERO), provided an update regarding the HERO Program and spoke in favor of the County adopting this program for the unincorporated areas in the County.

George Apostolopoulos, Regional Manager of Ygrene Energy Fund, noted that they provide Property Assessed Clean Energy (PACE) financing. He spoke regarding the benefits of PACE financing and in support of the HERO Program.

Tom Orvis from the Stanislaus County Farm Bureau thanked the Board for their support in response to the California Water Boards Revised Draft Substitute Environmental Document (SED). Chairman Chiesa noted the tremendous support for the community during the SED hearings held by the Water Resources Board.
