He noted the potential impacts on the County and local governments including the elimination of the of state and local income tax deduction for individuals, potential reduction in home values, possible decrease in donations to charitable organizations, elimination of refinancing for County bond debt, and the elimination of private non-profit tax exempts bonds. It is anticipated that the tax reform bill will move to the House of Representatives floor next week.
