A moment of silence was held for Former Stanislaus County Auditor-Controller Wallace Morrow.

Invocation was given by Pastor Michael Schiefelbein with College Avenue United Church of Christ.

Chairman DeMartini spoke about the Adopt a Pet program and Stanislaus Animal Services staff presented a dog that is eligible for adoption.

Chairman DeMartini thanked the representative from the California Highway Patrol for attending the Board of Supervisors meeting today.

Carmen Sabatino spoke regarding the Korey Kaufman case and wiretapping.

Mitchell Davis noted the professionalism of the County staff working on Commercial Cannabis Program and apologized for his previous comments.

Bob Madearos voiced concerns regarding the shortage of beds for serious mentally ill patients.

Loretta Carhart requested that County Transit work with City of Modesto Transit regarding buses stopping at Kaiser Hospital.

Debra Harper voiced a complaint regarding the Sheriff's Department, and noted they recommended that she file a formal complaint.

- **6.C.3** Finds that all subdivision improvements for tentative parcel map 99-05 Bonita Ranch Unit 6 (formerly known as Sunray Estates), required by the Subdivision Improvement Agreement and executed by Bright Development, a California Corporation, have been installed to the satisfaction of Stanislaus County and Keyes Community Services District; accepted the subdivision improvements for tentative parcel map 99-05, Bonita Ranch Estates, Unit 6, and release of Performance and Labor and Materials Bonds; rescinded the previous rejection of road rights of way for Bonita Ranch Estates, Unit 6, recorded in Book 44 of Maps at Page 48, and accepted said road rights of way; finds that the said agreement was recorded on 09/14/2017, as Document No. 2017-0067366-00 and filed with the Stanislaus County Clerk Recorder's Office; authorized the release of Performance Bond No. 0711544 issued by International Fidelity Insurance Company in the amount of \$615,605.00 pursuant to section 66499.7(a) of the Subdivision Map Act; and, authorized the release of Labor and Materials Bond No. 0711544 issued by Developers Surety Indemnity Company in the amount of \$307,803.00 pursuant to section 66499.7(b) of the Subdivision Map Act, upon receipt of a Mechanic's Lien Guarantee - PW 2018-52

Chairman DeMartini announced that President Trump gave out the Fake News Awards.

CEO Hayes gave an update regarding the Governor's 2018-2019 Proposed Budget, which was released on 01/12/2018. He noted that the Proposed Budget includes funding for the State's "rainy day fund", design of our local Stanislaus Courthouse with a commitment for future funds for construction, and creates new high school technical education programs. CEO Hayes reported that there are no major negative impacts to the County, but noted that Stanislaus is 1 of 12 underfunded counties in California for child support services and our State advocates are working to seek increased funding for child support leading up to the May Revised Budget.
