Invocation was given by Mark Davila, Modesto's 2<sup>nd</sup> Ward, Church of Jesus Christ of Latter-day Saints.

Vanessa DeLeon, with the National Association for the Advancement of All People, presented Sheriff Christianson with a plaque for his dedication and commitment for the advancement of all people.

Frank Johnson, representing Interventional Health Administrative Services (IHAS), spoke regarding the services they provide. He requested assistance from the County in obtaining a mobile unit for IHAS.

Virginia Ehrler, a SEIU member, noted that she would like to meet with the Board regarding the current labor negotiations.

Samantha Carballo, Social Worker with Adult Child Family Services Division and a SEIU member, spoke about the difficult job that they perform. She asked that the Board sit down and talk with them.

Gabriel Miramontes, SEIU member, spoke in support of wage increases, changes to shift requirements, and bereavement policy changes.

Judy Marable, Pediatric Physical Therapist and Christine Van Gorkin, Occupational Therapist, spoke in support of pay increases and the need to retain and recruit therapists.

Ron Dafford voiced concerns regarding his interactions with the Board of Supervisors office.

Shari Johnson, a Social Worker for Child Protective Services, stated that she would like to sit down with the Board of Supervisors to discuss their needs.

Marisa Caratachea, a Clinician and SEIU member, noted that in the past they purchased supplies themselves and that they are understaffed.
