The Board of Supervisors convened at 5:30 p.m. for Special Session

The Board of Supervisors reconvened at 6:30 p.m. for Regular Session

Invocation was given by Reverend Chuck Adams with Optimal Hospice.

Kathy Harwell, Director of CSA, gave a presentation and received a resolution proclaiming 07/21/2019 as Centennial Day for CSA upon their 100th anniversary of providing services to the community.

A presentation was given by David Wallace and Mercedes Wallace regarding the DW61 Foundation (Dennis Wallace Memorial Foundation) and they presented a check to the Stanislaus County Sheriff's Explorer Post.

Mathew Steinberg spoke regarding his difficulties in getting a corrective action plan for the Bloomingcamp Ranch's small water system approved.

Reid Johnson, Civil Engineer, spoke regarding the difficulty in operating small water systems.

Francisco Diaz requested that the audit cycle for the Monterey Tract Park Community Services District be changed to every 3 years.

Maree Hawkins, from the Friends of Stanislaus County Library, provided a letter and spoke regarding the recruitment and the importance of the Stanislaus County Librarian.

Warren Yates from the Stanislaus Taxpayer Association voiced concerns regarding the cost of the Korey Kauffman case.

Miguel Donoso spoke regarding discrimination of immigrants in the community, and the recent actions by the federal government.

John X. Mataka from the Grayson Neighborhood Council and Valley Improvements Projects spoke regarding the fear in the Latino Community due to the U.S. Immigration and Customs Agency (ICE) raids.

Carmen Sabatino read a letter dated May 2017 from Todd Spitzer, when he was an Orange County Supervisor, which requested an intervention from the Department of Justice to address issues in their District Attorney's office. He stated that the Stanislaus Taxpayer Association has formed a Political Action Committee to recall the Stanislaus District Attorney.
