Public Health Officer Dr. Vaishampayan, Director of the Health Services Agency Mary Ann Lilly-Tengowski, and CEO Hayes provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County.

Chairwoman Olsen acknowledged receipt of written public comments. She noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Samuel Bosshardt voiced concerned regarding government overreach in response to COVID-19 and he noted that he is working to schedule a public demonstration.

Chiesa/DeMartini (3-0)(Withrow abstained)(District 4 vacant) **Authorization for an Item Too Late For Agenda A** – Pursuant to Government Code section 54952.2(b)(2), the Board finds that there is a need to take immediate action to approve adding an item to the agenda to consider an appointment to the Western Hills Water District Board of Directors to fill the vacancy left by the resignation of Barry Ivy; the need for action came to the attention of the County on Sunday, 11/29/2020, after the Board agenda was already posted; and, approved adding an item too late for agenda and placed the item on this agenda titled "Approval of Appointment to the Western Hills Water District Board of Directors" – County Counsel 2020-0647
