February 9, 2021

Invocation was given by Pastor Michael Schiefelbein with College Avenue United Church of Christ.

A presentation was regarding the Youth Assessment Center by Chief Probation Officer Mike Ferriera, Juvenile Probation Manager Dave Chapman, and Karina Franco with Sierra Vista Child and Family Services.

Public Health Officer Dr. Vaishampayan, Deputy Fire Warden Erik Klevmyr and CEO Hayes provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County.

Chairman Chiesa acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Bryan Evitt recommended that the County target vaccinations for the COVID-19 hot spots. He voiced complaints regarding the Sheriff's department response to his growth of cannabis seedlings. He also shared that he was having difficulty in obtaining a nursery permit from the County.

Donna Riley, Treasurer/Tax-Collector, spoke regarding the property tax postponement program and eligibility requirements. She noted that the deadline to apply for this program for this year ends tomorrow.

Withrow/Grewal unan. **8.3** Approved the process and initiated the Stanislaus County Supervisorial Redistricting for 2021 consistent with supervisorial redistricting requirements; approved the formation of the Redistricting Steering Committee and the Redistricting Project Team, and directed staff to return with recommendations for membership of these committees; approved the establishment of an Ad Hoc Citizen Advisory Redistricting Commission and that it be composed of 11 members: 5 chosen by each of the board members from an applicant pool representing their respective district; 5 members residing in each

district chosen at random; and an 11th member chosen at random from any district; and directed staff to return with recommendations for appointment to this commission; and, approved the application period for the Ad Hoc Citizen Advisory Redistricting Commission to occur from 02/12/2021 through 03/12/2021 and directed the Clerk of the Board to post vacancies and authorized the Clerk of the Board to accept applications – CEO 2021-0052

Chairman Chiesa clarified an earlier public comment regarding Sheriff Deputy salaries. He noted that Stanislaus County Sheriff Deputies are paid less than Orange County Sheriff Deputies but are paid salaries consistent with our eight comparable counties.

CEO Hayes shared that the Board sent a letter to Assemblymember Gray in support of the COVID-19 Small and Essential Business Tax Credit. He reported that staff is working with our Central Valley partners to advocate at the State level on a variety of issues and there is a virtual meeting scheduled for this Friday.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
