Condit unan. **8.1** Conducted a public hearing to consider the Planning Commission's recommendation of approval for Ordinance Amendment application number PLN2020-0105 – Hemp Cultivation; finds that: (a) no further analysis under CEQA is required pursuant to CEQA Guidelines Section 15183 (Consistency with a General Plan, Community Plan or Zoning Ordinance for which an Environmental Impact Report (EIR) was prepared), on the basis of the whole record, including any comments received in response to the Environmental Review referral; (b) the project is consistent with the development density established by existing zoning, community plan or general plan policies for which an EIR was certified; (c) there are no project specific effects which are peculiar to the project or its site, and which the 2016 Stanislaus County General Plan Update (GPU) EIR failed to analyze as significant effects; (d) there are no potentially significant off-site and/or cumulative impacts which the GPU EIR failed to evaluate; (e) there is no substantial new information which results in more severe impacts than anticipated by the GPU EIR; (f) the project will undertake feasible mitigation measures specified in the GPU EIR; finds the project is generally exempt for the CEQA pursuant to CEQA Guidelines Section 15061 and ordered the filing of a Notice of Exemption with the Stanislaus County

Clerk-Recorder pursuant to CEQA Guidelines Section 15062; finds that there is no substantial evidence the project will have a significant effect on the environment and that the exemption reflects Stanislaus County's independent judgement and analysis; finds the project is consistent with the overall goals and policies of the Stanislaus County General Plan; and, approved Ordinance Amendment application number PLN2020-0105 - Hemp Cultivation, as recommended by the Planning Commission and with the amendments as outlined in the Board report, and introduced, waived the reading, and adopted Ordinance C.S. 1293 – Planning
