May 11, 2021

Invocation was given by Mike Gunnarson from City Ministry Network.

The CEO announced that the Stanislaus County Employee' Retirement Association (StanCERA) presentation was postponed to a future date.

Public Health Officer Dr. Vaishampayan, Director of the Health Services Agency Mary Ann Lilly-Tengowski and CEO Hayes provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County.

Bryan Evitt suggested a customer service survey after interaction with the Sheriff's Department instead of forming a Citizens Oversight Committee. He also spoke regarding the need to make the community safe for the poor.

Miguel Donoso shared concerns regarding the formation of the Stanislaus Homeless Alliance Board and conflict of interests.

John X. Mataka from the Grayson Neighborhood Council and Valley Improvements Project spoke regarding the lack of certified Spanish-speaking attorneys at Juvenile Hall. He voiced concerns regarding the fire at the Covanta Incinerator and does not want the County to renew their contract. He also shared concerns regarding the opiate death-rate in Crows Landing and would like an increase in the prevention programs targeting the West Side.

Kyle Kowalski, Field Representative for Carpenters Union Local 152 in Manteca, shared concerns regarding a construction company listed in item 6.B.10 on today's agenda.

Supervisor B. Condit complimented Angela Freitas and David Leamon, and their respective departments, on their work in resolving constituents' issues in a satisfactory manner and timeframe.

CEO Hayes reported that the State anticipates over \$100 billion dollars in discretionary spending for the 2021-2022 State budget. The Governor's office will be recommending appropriations in various areas including: Child Care Services, an extension to the Golden State Stimulus, and, an increase in emergency rental assistance. The CEO noted that Governor Newsom has declared a drought for forty-one counties including Stanislaus County. The May Revised State Budget is expected to be released this Friday. CEO Hayes will bring a preview of efforts to strategize American Rescue Plan Act (ARPA) funding to the Board at a future meeting.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
