- **6.D.1** Rescinded all of Williamson Act Contract No. 1973-1470, located north of John Fox Road, between the Tuolumne River and the TID Ceres Main Canal, in the Hughson Area, APN 019-003-001, Pursuant to Government Code Section 51257, determined that the following seven findings can be made based on the written evidence submitted by the applicant; (a) the new contract, or contracts, would enforceably restrict the adjusted boundaries of the parcels for an initial term for at least as long as the unexpired term of the rescinded contract, or contracts, but for not less than ten years, except as authorized under the County's implementation of AB 1265; (b) there is no net decrease in the amount of the acreage restricted, in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contract is at lease as great as the aggregate acreage restricted by the rescinded contracts; (c) at least 90 percent of the land under the former contract, or contracts, remains under the new contract, or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Government Code Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel

or other agricultural lands subject to a contract, or contracts; (f) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan; approved a new contract, pursuant to the Lot Line Adjustment Application No. PLN2021-0011, Geer Rd Ranch and Martella – Lowe Road; and, authorized the Director of Planning and Community Development to execute a new contract – Planning 2021-0230

B. Condit/Grewal unan. **8.1** Authorized the CEO, or his designee, to issue a revised termination notice to the Mountain Valley Emergency Medical Services (MVEMSA) Joint Powers Agency for withdrawal of Stanislaus County from this Agency, to be effective 06/30/2022; authorized the Managing Director of HSA, or her designee, to negotiate and execute an agreement with MVEMSA to administer local emergency medical services for FY 2021-2022; and, directed staff to develop a financial forecast and staffing plan to administer local emergency medical services for Stanislaus County as a single-county administrator, effective 07/01/2022, and an alternative financial forecast and staffing plan for multi-county capability and return to the Board with recommendations by 08/31/2021 – HSA 2021-0231
