Public Health Officer Dr. Vaishampayan, Director of the Health Services Agency Mary Ann Lilly-Tengowski, and CEO Hayes provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County.

Joe Lizzaraga, Manager of Recology Blossom Valley Organics, acknowledged and presented the 2021 Recology Scholarships Award recipients: Angelica Hernandez, Abimelec Ruano, Lizbeth Juarez-Gutierrez, Michael Alamo, and Shaila Wilkerson. Debra Harper voiced concerns on her removal from Wal-Mart and her suspension from riding the bus today. She spoke regarding the need for everyone to peacefully co-exist and function.

Supervisor C. Condit shared that he participated in the Crows Landing Community Clean-Up effort this past Saturday and thanked County staff Erica Inacio and Russell Fowler, Newman Fire Department, Chief Bowen, Crows Landing Lions Club, and all of the citizens from the community. The team were able to fill seven large Bertolotti yard waste bins. It was a wonderful day on the west side.

Supervisor B. Condit recognized Jeff Jennings, varsity basketball coach from Riverbank High School who coached his last basketball game last week. He presented Coach Jennings with a certificate and celebrated his 25 years of mentoring and teaching the young men of Riverbank.

Supervisor Chiesa congratulated Reverend Ernie Spears, who celebrated his 50^{-year} anniversary as the Pastor of Assembly of God, in Hughson, of the church's 75 years of existence on Saturday. He noted that Pastor Spears was responsible for starting the Fruit and Nut Festival in Hughson.

Supervisor Withrow thanked Liz, Clerk of the Board, for her being available to clerk meeting. He shared his heartfelt concern for her and her family during this time.

CEO Hayes reported that the House of Transportation and Infrastructure Committee released its federal infrastructure bill which includes \$6.5 million for the County's 7th Street Bridge, and \$12 million for SR132 projects. The State legislature passed the 2021-2022 state budget bill and it's on its way to the Governor. The County submitted letter of support to Senator Caballero regarding SB-28, Rural Broadband and Digital Infrastructure Video Competition Reform Act of 2021. The CEO also reported that a water challenge was being experienced by the community of Westley during the meeting.
