The CEO noted that the County has sent advocacy letters to our State representatives regarding psychiatric health facilities, and regarding the financial support and penalty structure around County IHSS programs.

Chairman Chiesa announced that the Annual Fireworks Celebration at Woodward Reservoir is on Saturday, July 3, 2021 at 9:30 p.m., located at 14528 26 Mile Rd., Oakdale.
