Invocation was given by Laura Williams from The Church of Jesus Christ of Latter-day Saints, Modesto Stake.

Kathryn Harwell, Director of the Community Services Agency, was recognized upon her retirement from Stanislaus County.

Lisa Mantarro Moore, Executive Director of Family Justice Center of Stanislaus County, gave a presentation.

Public Health Officer Dr. Vaishampayan, Director of the Health Services Agency Mary Ann Lilly-Tengowski and CEO Hayes provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County.

Leonard Powell shared concerns over the Salida Gas Station Project and shared his opposition of the project.

Marcie Powell voiced concerns regarding the Salida Gas Station Project.

Miguel Donoso expressed concerns for low income minority families that were affected by COVID-19.

Melissa Kelly honored Patricia "Patty" Stone, who recently passed away, and the work she did with the Salvation Army. She added that she wants the community to keep safe and supports the nurses in attendance.

Daniel Machado shared support of the nurses and doctors within the healthcare system and opposes the State's vaccine mandate.

Madalynn Baker voiced concerns regarding the nurse to patient ratios in the hospitals. She also shared concerns about the polymerase chain reaction (PCR) test.

Nita Brady shared concerns regarding the information gap of the COVID-19 vaccine. She is in support of the healthcare workers that she has worked alongside over the years.

Amanda Lowell spoke in opposition of the State's healthcare vaccination mandate and shared concerns regarding the vaccination.

Keryn Whitlow requested the Board's support and guidance regarding the State's vaccine mandate for healthcare workers.

Charmaine Peterson spoke about Constitutional Rights and Freedoms. She shared concerns regarding the State's healthcare vaccination mandate. She requested the Board's help and support to represent their voices at a State level.

Jordan Hertwig expressed concerns about the State's vaccine mandate for healthcare workers and requested a reasonable alternative to this mandate.

Devony spoke in opposition of mandatory healthcare vaccination. She shared concerns about how the mandate will affect her community and future patients and requested the Board's help to restore healthcare workers' freedom to make their own medical choices.

Shannon Mazzone shared concerns about making a choice of her own.

Michael Weber voiced concerns regarding the COVID-19 vaccine and requested the Board's help opposing the vaccine mandate.

Chanel Mendoza spoke to advocate for the medical and human rights for all of the nurses and medical professionals. She shared concerns regarding the COVID-19 presentation. She would like to ally with each of the Board members regarding informed consent.

Perry Landes expressed concerns regarding COVID-19 vaccine information.

Jessica Climer shared concerns about the State's vaccine mandate for healthcare workers. She requested the Board's help in opposing this mandate.

Ginger Parrish expressed concerns regarding the State's vaccine mandate and requested the Board's help to protect their rights.

Aundrea Covey shared concerns over the vaccine mandate and one's right to choose.

Kim Van Der Maaten voiced concerns regarding the State's vaccine mandate for healthcare workers.

Rachelle expressed concerns regarding the State's mandate requiring medical staff to be vaccinated in order to work.

Babette shared concerns about her daughter's school requiring her to be vaccinated in order to continue her education.

Steven Morrow requested the need for the Board to interface with the State and try to come to some realistic work between Federal, State and Local authorities to try and address everyone's needs and get COVID-19 under control.

Shannon Mazzone shared concerns regarding COVID-19 and the State's mandate.

Billy requested the Board step in at a State level and do it now, so those in the medical field do not have to make the choice that they don't want to make.

Remy expressed her opposition to the State's vaccine mandate.

Samuel Bosshardt shared concerns over the indefinite state of emergency and requested the Board to be their voice against this State mandate.

Jessica expressed how the community will suffer due to this mandate being posed on the medical workers. She shared how the loss of medical staff will be felt community-wide and requested the Board to be their voice against the State mandate.

Alexis shared concerns regarding the State's vaccine mandate and requested the Board to fight for medical staff.

Rebecca shared her father's immigration story and her opposition to the government's involvement in healthcare. She requested the Board to stand up for healthcare staff.

Ashley expressed concerns regarding the government and her employer having a right to make medical decisions on her behalf and requested the Board support her right to choose.

- **5.D.1** Set a public hearing on 08/31/2021, at the 9:00 a.m. meeting, to consider the Planning Commission's recommendation of Rezone Application No. PLN2019-0108, Price Honda, a request to rezone a 5.14 acre parcel from expired Planned Development (P-D) (209), to a new P-D to allow for development of an auto dealership in two phases, located at North Golden State Boulevard, between West Barnhart and West Taylor Roads, in the Keyes/Turlock Area; and, authorized the Clerk of the Board to publish a notice of public hearing as required by law Planning

- **5.D.2** Rescinded all of Williamson Act Contract No. 1978-3072, located southwest of the Pioneer Avenue and Lone Tree Road intersection, in the Valley Home area APN 002-010-026; finds that pursuant to Government Code §51257, determined that the following seven findings can be made based on the written evidence submitted by the applicant: (a) the new contract, or contracts, would enforceably restrict the adjusted boundaries of the parcels for an initial term for at least as long as the unexpired term of the rescinded contract, or contracts, but for not less than ten years, except as authorized under Stanislaus County's implementation of AB 1265; (b) there is no net decrease in the amount of the acreage restricted, in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; (c) at least 90 percent of the land under the former contract, or contracts, remains under the new contract, or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Government Code Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract, or contracts; (f) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan; approved a new contract(s), pursuant to Lot line Adjustment Application No. PLN2017-0122, Hogan-Parodi; and, authorized the Director of Planning and Community Development to execute a new contract(s) – Planning 2021-0376

Condit (4-0)(Grewal absent) **7.1** Authorized the CEO, or his designee, to negotiate and execute an agreement with the Stanislaus Community Foundation for no more than \$450,000 for a consulting engagement in support of the STANISLAUS 2030 economic development initiative; and, authorize the Auditor-Controller to increase revenues and appropriations as included in the budget journal attached to the agenda item CEO 2021-0377

Chairman Chiesa shared that the Oakdale Chocolate Festival and the Riverbank Wine and Cheese Festival are still on for this year. He also spoke about yesterday's ribbon cutting at the Turlock Library and said today is the official opening of the library. He thanked Pat Portwood, President of the Friends of the Turlock Library; Patricia Hill Thomas, Project Manager; LDA Architects; Roebellen Construction and all the Library employees.

Supervisor Withrow commended Chairman Chiesa for his continued advocacy for the Turlock Library.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
