Public Health Officer Dr. Vaishampayan, Director of the Health Services Agency Mary Ann Lilly-Tengowski, and CEO Hayes provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County.

John Mataka read a letter written by Noe Paramo, Legislative Advocate CRLA, in support of race equity and social justice.

Cherise Babb, Social Services Assistant, spoke in support of In-Home Supportive Services (IHSS) reclassifications of her unit.

Maria Delgado, Social Services Assistant, spoke in support of the IHSS reclassifications.

Loren Cruz, Social Services Assistant, shared the importance of client services and IHSS. She added that she supports the reclassification of IHSS.

Joslyn spoke on behalf of Nadia Ramos, Social Services Assistant, requesting the Board consider their request to reclassify this group of Social Service Assistants to IHSS Provider Coordinators and Registry Specialists.

Angela Guzman, Supervising Account Administrative Clerk II, shared support for IHSS reclassification of this unit.

Miguel Donoso spoke in support of the letter that John Mataka read regarding race equity and social justice.

Karyn Clark shared concerns regarding the restructuring of BHRS and spoke in support of a wage increases.

Supervisor C. Condit shared that his office was contacted by two disabled seniors who were living on the streets. He reported a positive outcome in finding the couple a shelter and thanked CSA for their help in this coordinated effort.

Supervisor Grewal shared that a couple of weeks ago the Sheriff wrote an Op-ed about alarming numbers of rearrests for people who are released before serving their full term in State prison. He asked the Sheriff to give a presentation to the Board in the future on this topic and on zero bail.

Supervisor B. Condit shared he participated in the Oakdale Chamber of Commerce Fundraiser "Arrest Round-Up!" last week and thanked his colleagues for bailing him out, proceeds of the fundraiser benefit the Oakdale Scholarship Fund. He announced that he is taking the month off for holding his mobile office hours, during this delta variant increase; however, he looks forward to being in Waterford next month.

Chairman Chiesa updated Supervisor C. Condit on his request for a presentation on water regarding the State Water Board's letter of curtailments. He noted that he spoke with TID and is working to get the presentation arranged.

CEO Hayes reported that last week Senator Eggman visited the BHRS Recovery Center and Supervisors Withrow and Chiesa were able to join. He thanked Senator Eggman and BHRS staff for coordinating this meeting. He also acknowledged that on Tuesday, 08/10/2021, the Senate passed the Bipartisan Infrastructure Package. He mentioned that next week he has meetings with Supervisor Withrow and Supervisor B. Condit to further discuss the vaccine mandate for health care workers with our State Legislature. CEO Hayes thanked Senator Padilla for the letter of support regarding the Economic Development Administration Grant. Lastly, he mentioned that last week information was released regarding the Redistricting Workshops and encouraged the public to participate and be part of the process. Chairman Chiesa complimented Senator Eggman on her knowledge and expertise on mental health.
