## Convened at 5:30 p.m. for Special Session

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.

Labor Organizations: Stanislaus County Employees Association, American Federation of State, County & Municipal Employees Local 10; Service Employees International Union, Local 521; County Attorney's Association; Deputy Sheriff's Association; Stanislaus Regional Emergency Dispatchers' Association: Stanislaus County Probation Corrections Officers' Association; Stanislaus County Sheriff's Management Association; Stanislaus County District Attorney Investigators' Association; and, Stanislaus Sworn Deputies Association; and Stanislaus Regional Emergency Dispatchers Association. No reportable action was taken.

A moment of silence was held for Stanislaus County Community Services Agency employee Christy Costa.

Invocation was given by Marvin Jacobo from City Ministry Network.

Yamilet Valladolid, Latino Business Association Foundation and Hispanic Leadership Council; Aaron Anguiano, President of the Latino Community Roundtable; and, Johnny Garcia, CEO of the Central Valley Hispanic Chamber of Commerce received a resolution proclaiming September 15 - October 15, 2021 as Hispanic American Heritage Month in Stanislaus County.

CEO Hayes, Public Health Officer Dr. Vaishampayan, Director of the Health Services Agency Mary Ann Lilly-Tengowski, and the CEO of Memorial Medical Center, Gino Patrizio provided an update of the 2019 Novel Coronavirus (COVID-19) Emergency and Essential Services in Stanislaus County.

Steve Morrow spoke regarding the federal budget and asked the Board to carefully consider the County budget on today's agenda.

Julie Key, Licensed Mental Health Clinician with BHRS, expressed concerns regarding the vaccine mandate, weekly testing, and requests for exemptions for Stanislaus County employees.

Elizabeth Vega shared her concerns regarding the vaccine and encouraged vaccinated or unvaccinated people to come together to serve one another in love, not hatred or confusion.

Keryn Whitlow spoke regarding the COVID-19 webpage not working and that it lacks education. She suggests we provide education on alternatives and work together.

Savmear spoke regarding the consequences of isolation on mental health during COVID-19 and noted the increase in suicide among youth. He voiced concerns regarding the potential of his father's employer requiring vaccinations.

**9.2** Conducted the public hearing to consider the adoption of the Recommended Final Budget for Fiscal Year 2021-2022 of Budget Period 2020-2021/2021-2022 and related actions; and, amended the item to take **two votes as follows:** 2021-0445

**First Vote:** B. Condit/C. Condit (4-1)(Chiesa opposed) **Amended** Staff Recommendation No. 2 to read as follows: "Consider the allocation of \$1,120,620 of Proposition 172 Public Safety Sales Tax revenues to support fire districts, to be paid directly to individual fire districts negatively impacted by the State's Educational Revenue Augmentation Fund (ERAF) shift and \$120,244 to be paid to the Sheriff – Office of Emergency Services/Fire Warden to administer for the benefit of volunteer fire districts"; and, approved Staff Recommendation No. 2 as amended.

Second Vote: C. Condit/B. Condit unan. Approved Staff Recommendations No. 1 and Nos. 3 – 10 as follows: (1) Accepted the 2021-2022 Recommended Final Budget from the CEO and recognized the new Stanislaus County mission statement, We build community, and vision statement, Becoming a community of choice, where people live, work and thrive, a place worthy of calling home; (3) conducted the public hearing to receive public comment and input on the recommended operational plan for FY 2021-2022, which provides the annual operational plan for the organization and spending authority of approximately \$1.5 billion; (4) adopted the 2021-2022 Recommended Final Budget; (5) approved the restoration of the Contingency Reserve by increasing the General Fund assignment by \$1,505,000, consistent with the Contingency Reserve Policy to retain at least 8% of the average annual Discretionary Revenue receipts from the preceding three fiscal years to mitigate exposures to the General Fund; (6) authorized the CEO and Auditor-Controller to make the necessary technical adjustments to implement the 2021-2022 Adopted Final Budget; (7) directed the CEO and the Auditor-Controller to prepare the Adopted Final Budget document and supporting schedules in accordance with State law and submit to the State Controller prior to 12/01/2021; (8) amended the Salary and Position Allocation Resolution to reflect the recommended changes for the 2021-2022 Recommended Final Budget, as outlined in the Staffing Impacts section of the report and detailed in Attachment 2, of the agenda item, to become effective the start of the first full pay period on or after 09/25/2021, unless otherwise indicated; (9) approved contracts and/or agreements listed

on Attachment 3, of the agenda item, in cumulative amounts of \$200,000 or greater since 07/01/2019, and authorized the GSA Director/ Purchasing Agent or previously authorized Department of Head to sign; and, (10) approved a total appropriations/budgetary limit for annual appropriations of tax revenue for FY 2021-2022 in accordance with the provisions of Proposition 4 and 111, and established a General Operating Limit of \$457,621,958 using the Population and Inflation Methodology, per Attachment 6 of the agenda item – CEO

Supervisor C. Condit reported that he served on the Election Observer Panel for the California Gubernatorial Recall Election last week. He acknowledged that Donna Linder, Registrar of Voters, and her staff did a phenomenal job.

CEO Hayes noted that the 2021 Legislative Session has ended in Sacramento and there are numerous bills on the Governor's desk. Staff is tracking the bills that will have an impact on the County. He shared that the Redistricting Workshops have begun, and a virtual workshop has been added for 09/30/2021 from 6-8 p.m. The CEO noted that information is available at <u>www.stancounty.com/redistricting</u> and or by calling the CEO's Office at (209)525-6333. He also announced in accordance with Government Code Section 54953(c)(3), that he appointed Community Services Agency Director Amanda Sharp at a starting salary of \$195,000, plus Department Head benefits, and the Director of Environmental Resources Robert Kostlivy at a starting salary of \$160,000, plus Department Head benefits.
