Supervisor Chiesa shared that Jeanne Henley and Ron and Jane Martella were recognized last weekend at the Fruit and Nut Festival in Hughson. He reported that the County conduced enforcement of illegal cannabis grows this weekend in Hickman, Denair and Riverdale Park Tract areas.

Supervisor Grewal participated in Love Stanislaus County, Love Modesto and Love our Cities this past weekend and said it was great and well attended.

Supervisor Withrow thanked Jeff Pishney and the Downtown Streets Teams for all their efforts in the Love Modesto event. He said he is looking forward to the Cinco de Mayo celebration on Saturday, 5/07/2022.

CEO Hayes reported that this week is the deadline for bills to get out of committee and move forward at the State Legislature. Staff is watching closely AB 2201, which concerns groundwater extraction permitting requirements. He noted staff met with Senator Eggman's office to discuss the CARE Court proposal from the Governor. He shared there was an award through the Homekey Program of \$1.7 million to the City of Modesto for a project that is a partnership with the STEP Program. CEO Hayes also introduced a new CEO Management Consultant Regina Menezes.
