Invocation was given by Pastor Lyn Crase, from Emmanuel Lutheran Church.

Supervisor Grewal recognized John Jacinto as the Iron Valley Powerlifting Champion.

Former County Supervisor Jim DeMartini greeted the Board and shared that he was visiting from out of State.

Joseph Monterosso asked the Board to remind County Counsel that the 30-day time period to reply to the lawsuit he filed against the County concerning the dirt strip adjacent to his property is up this Friday. He shared concerns regarding this dirt strip adjacent to his property.

CJ Kannusis, IHSS provider, shared concerns regarding the current IHSS wages and proposed wage increase of .75 cents. He noted that IHSS providers should have a living wage.

Irene Cortez, spoke regarding the Relay for Life on 10/08/2022 at 9:00 a.m. - 10/09/2022 at 9:00 a.m. at John Thurman Field, 601 Neece Drive, Modesto. She thanked Chairman Withrow for agreeing to present a proclamation at this event and invited the entire Board to attend this event.

Susan Beasley invited the Board to attend the International Heritage Festival on 10/01/2022 10:00 a.m. to 3:00 p.m. at the Graffiti USA Classic Car Museum, 610 N. 9th Street, Modesto.

Melinda Screeton spoke regarding the UTurn Project in Oakdale and shared it has partnered with the Oakdale Rescue Mission. She asked the Board for help in turning over a piece of property at 525 Center Street to the City of Oakdale to build overnight housing. She thanked Supervisor B. Condit for coming out to Oakdale to learn about this project. She also shared concerns regarding mental health services offered in Stanislaus County.

Rebecca Harrington acknowledged her appreciation for the reminder today of housekeeping rules in the chambers. She shared concerns regarding projects in the community that do not get any action or traction. She commended IHSS providers for the work they do and supports a wage increase for these providers. She requested a proclamation for the Día de Muertos event in Stanislaus County.

Louisa Bryant shared concerns regarding a Mold Inspection Report conducted at her apartment complex provided handouts to the Board.

Terry Walker-Dampier shared concerns regarding fast food workers receiving \$22.00/hr. and asked the Board to please provide IHSS workers a livable contract.

Corie Crowson, IHSS provider in Merced County, shared concerns regarding IHSS wages. She expressed concerns regarding the older adult population growing and the need for IHSS workers. She asked the Board for a benefit package that allows caregivers to keep doing this work.

Teresa Tovar spoke in support of IHSS providers wage increase. She shared concerns regarding AB257 being signed and fast food workers making higher wages than IHSS providers.

Astrid Zuniga, IHSS provider for adult son, shared she attended the Statewide Aging, Disability and Equity Planning Conference today. She shared that every conversation today spoke about investing in our community. She shared concerns regarding current IHSS wages and noted she hopes next week when she attends the IHSS meeting they are presented a better benefit package.

Sebastian Jones, IHSS provider, shared concerns regarding IHSS wages. He requested a \$4.00/hr. wage increase and asked the Board to make this wage increase a priority.

Margarita Enriquez, IHSS provider for her mother, shared concerns regarding being paid for only 20 hours of care for her mother. She expressed concerns regarding paying for personal needs for her mother. She also noted she must work overtime to make a livable wage.

Maria Alonso, IHSS provider for her son, shared concerns regarding the cost of living increases. She expressed that these providers deserve a wage increase.

Matiana Lujan, IHSS provider for her daughter, shared concerns regarding the need to be able to care for her daughter and expressed concerns about having someone else care for her.

Sofia Rodriguez shared concerns regarding unemployment rates for IHSS providers in Stanislaus County versus Alameda County. She expressed concerns regarding current wages and shared that an increase to \$17.00/hr. would still not be high enough wages.

Zenaida Velasquez, IHSS provider for son who is deaf and mute. She expressed \$15.50/hr. is not high enough wages and \$17.00/hr. is not enough either. She asked the Board for livable wages.

Fidelina Canela, shared her daughter provides IHSS services to her. She expressed concerns regarding her daughters' wages. She asked the Board for a wage increase for her daughter.

Cornelius Cisneros, IHSS provider for mother, shared concerns regarding the need for higher wages.

Rebecca Harrington noted that a parent that who provides IHSS services for their child must go through an expensive conservatorship process once the child turns 18 years old.

Howard Carman spoke in support of IHSS providers. He asked the Board to offer these providers prevailing wages.
