Invocation was given by Pastor Lonnie Skiles, with Big Valley Grace Community.

A commendation was presented to Public Health Officer Julie Vaishampayan, M.D. upon her retirement from Stanislaus County.

Chairman Withrow acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Joseph Monterosso voiced concerns regarding the County's response and the spending of public funds regarding his lawsuit against the County concerning a dirt strip adjacent to his property and provided handouts to the Board.

Steven Morrow reminded everyone that election season is upon us. He shared how important it is to prepare for the election and send in your ballot.

Miguel Donoso shared concerns regarding the lack of policies in place for the Diversity, Equity, and Inclusion (DEI) Manager position. He voiced concerns regarding County infrastructure and jobs and spoke regarding Executive Order 1395 not being implemented yet.

Ramon Rodriguez thanked Public Health Officer Dr. Vaishampayan for her contribution to the County. He shared concerns regarding the homeless population and the New State of California.

Deahna Washington shared that she appreciates the presence of Park Rangers in the Dr. Martin Luther King Jr. Park. She voiced concerns regarding the homeless in the park and their movement toward the front of her home due to the presence of the Park Rangers. She shared appreciation for the help she receives when coming downtown with issues that need resolution. She shared concern regarding the sale of the Municipal Golf Course and would like to see accountability for future investors.

Astrid Zuniga, IHSS provider for adult son, spoke in support of a wage increase and shared she would like to see a reasonable negotiated wage increase by the end of this week. She spoke regarding the Stanislaus 2030 plan and requested the County to set the bar for livable wages and benefits.

Kristi Ramos, IHSS provider for 15 years, spoke in support of a wage increase. She shared concerns regarding fast food workers earning higher wages than IHSS providers.

John Adam shared concerns regarding IHSS provider wages and supports a wage increase. He shared that these jobs are really needed.

Evelyn Landrough shared concerns about wages and work conditions of field workers. She voiced concerns regarding the need of affordable housing and higher wages.

Blanca Rivera, IHSS provider, shared concerns regarding IHSS wages and supports a wage increase. She shared these providers take care of people and keep them safe and without these providers the County would have to provide care.

Carolyn Vargas and Alfredo Vargas, IHSS providers for their adult son, support a wage increase for IHSS providers. She shared concerns regarding the need to provide 24/7 care and not being compensated appropriately. She asked the Board to do the right thing.

Elvia Solorio shared concerns regarding the lack of wages for IHSS providers supports a wage increase.

Ricardo Cervantes, spoke for his wife Christina Cervantes, who cares for their adult daughter. He requested a wage increase for IHSS workers.

Sofia Rodriguez, IHSS provider, shared she left her previous job to care for her mom. She shared concerns regarding IHSS wages and the pay cut she took in order to care for her mother. She also voiced the need for a wage increase in order to maintain IHSS providers.

Alejandra Pineda, IHSS provider for her adult nephew, requested a wage increase. She shared concerns regarding the current wages and the inability to afford things on her own and the stress this has caused.

Dela Perales, IHSS provider for parent, requested a wage increase for IHSS providers. She voiced concerns regarding the lack of concern for these providers. She shared they are just asking for a little bit more wages with the rising costs.

Wayne Junso, IHSS provider, spoke for his adult son who was unable to attend the meeting. He shared his son is asking for respect for IHSS providers. He requested a wage increase.

Bertha Amaya, IHSS provider for mother, spoke in support of a wage increase.

Azucena Anguiano, IHSS provider for son, shared concerns regarding IHSS provider wages and the increase in her debts. She requested a wage increase for IHSS providers.
