- **7.B.1** Declared an emergency in accordance with California Public Contract Code Section 22050 for emergency repair and replacement of the electronic security controls in the Juvenile Institutions, located at 2215 Blue Gum Avenue in Modesto; approved staff's recommendation to act in accordance with Public Contract Code Sections 20134 and 22050 to make the immediate repairs at the Juvenile Institutions; made the following findings: (a) the significant operational issues at the Juvenile Hall are occurring as the result of the failing security electronic controls systems, as well as discontinued parts and equipment for these systems, and are creating potential public safety issues; (b) the repairs are necessary to ensure the safety of Probation youth and to prevent the loss of essential public services; and, (c) the emergency will not allow for the delay that would result if the project were competitively bid, and the action to immediately repair the Agency's impacted systems on an emergency basis is necessary; directed the GSA Director/Purchasing Agent, or designee, to serve as the Project Manager for all aspects of the project; approved an initial project budget of \$840,000 funded by Probation department revenue, as detailed in the budget journal, attached to the agenda item; authorized the Project Manager to procure equipment and supplies, and to negotiate and execute contracts needed to repair the electronic system, without giving notice for bids to let contracts, so long as they are within the approved project budget; directed the Auditor Controller to increase appropriations and revenue as detailed in the budget journal, attached to the agenda item; and, required staff to report to the Board on the status of the emergency project, and to report contracts and services for the Board to ratify, at its next regularly scheduled meeting and every 14 days thereafter, as required by the Public Contract Code until the repairs are completed – GSA 2022-0697
