Invocation was given by Marvin Jacobo, with City Ministry Network.

Sheriff Dirkse provided an update on the local emergency due to winter storms and flooding impacting Stanislaus County.

Clarissa Hernlund, Senior Transit Planner with StanCOG, gave a presentation on the Unmet Transit Needs process.

Denise Dean with Home Is Where the Heart Is Ministry, shared she helps clothe and feed the homeless. She asked the Board to partner with her to purchase personal protective equipment (PPE), specifically jackets and rain ponchos for the homeless.

Steven Morrow shared concerns regarding the current scene in Washington, D.C. and shared the government needs to get the financial house in order but still needs to pay our debts. He also voiced concerns regarding racism.

Maria Arevalo, Chair of the Latino Giving Circle, shared she wants to be part of the Stan 2030 conversation and voiced concerns regarding farmworkers and undocumented citizens. She would like to see some of the surplus American Rescue Plan Act (ARPA) funds used for farmworker services and to aid the undocumented citizens in the County.

Dr. Ana Andrade, with the Latino Giving Circle spoke in support of using surplus American Rescue Plan Act (ARPA) funds for farmworker and legal services for the undocumented citizens in the County.

Miguel Donoso shared concerns regarding outreach not in Spanish or other languages and asked the Board to abide by Executive Orders 13985 and 13166.

Deborah Harper spoke regarding the importance of focusing on functioning and peacefully coexisting with each other.

Martha Villasenor with the Crows Landing Municipal Advisory Council, spoke regarding the status of the sidewalks and speedhumps with regards to the American Rescue Plan Act (ARPA) funds.

Chairman C. Condit acknowledged and thanked representatives from Congressman John Duarte's Office and Assemblymember Juan Alanis' Office for being here today.

Representative Gavin Klein from Congressman John Duarte's Office introduced himself and shared he looks forward to working with the Board and residents of Stanislaus County.

Representative Christan Santos from Congressman John Duarte's Office acknowledged OES staff; Emergency Coordinator Aaron Wilson; Deputy Director Erik Klevmyr; and, Deputy Fire Warden Chris Parnell for their assistance when they were notified of the damage at Shiloh Bridge. He shared he joined the Chairman at the MLK Unity March from the Helen White Trail to King-Kennedy Memorial Center last Monday. He also shared he joined the Board at the Frito Lay event for their Zero and near Zero Emissions event. He noted Congressman John Duarte has been given three committee assignments; Transportation and Infrastructure Committee; Agriculture Committee; and, the Natural Resources Committee.

Representative Justin Farkas from Assemblymember Juan Alanis' Office shared last week Assemblymember Alanis received his committee appointments and was appointed as the Vice-Chair of the Public Safety Committee. He was also appointed to the Agriculture, Budget, Business and Professions, Human Services, Water, Parks and Wildlife Committees. He shared he has had the opportunity to introduce four bills so far and fact sheets can be found in their office at 1010 10th Street, Ste. 5800, Modesto. He wanted to remind everyone that California is providing tax relief for those impacted by the storm and with an extension in filing your taxes until 05/15/2023 and there is also an opportunity to claim deductions for disaster loss.
