CEO Hayes reported that the State is targeting up to \$400 million in additional funding to support the health care workforce throughout the State.

Representative Bob Phelan from Congressman Tom McClintock's Office shared he is looking forward to meeting with each of the Board members and he is looking for an office in Modesto. He also shared he is happy to see the North County Corridor Project on the agenda and the Board taking action today.

Communications Director Karan Brar from Congressman John Duarte's Office shared they now have an office at 90 S. 1st Street, Turlock. He reported what the Congressman is working on in D.C. including the introduction of the Water for California Act, working with FEMA in response to the recent flooding in Merced and Stanislaus counties, and attending his first Transportation and Infrastructure Committee meeting.
