

NOTICE REGARDING NON-ENGLISH SPEAKERS: Pursuant to California Constitution Article III, Section IV, establishing English as the official language for the State of California, and in accordance with California Code of Civil Procedure Section 185 which requires proceedings before any State Court to be in English, notice is hereby given that all proceedings before the Stanislaus County Nuisance Abatement Hearing Board shall be in English and anyone wishing to address the Nuisance Abatement Hearing Board is required to have a translator present who will take an oath to make an accurate translation from any language not English into the English language.

ANY MEMBER OF THE AUDIENCE DESIRING TO ADDRESS THE NUISANCE ABATEMENT HEARING BOARD REGARDING A MATTER ON THE AGENDA: While the Nuisance Abatement Hearing Board welcomes and encourages participation in the meetings, it would be appreciated if comments are limited to five minutes so that everyone may be heard. Matters under the jurisdiction of the Nuisance Abatement Hearing Board and not on the posted agenda may be addressed by the general public following the completion of the regular agenda and any off-agenda matters before the Nuisance Abatement Hearing Board for consideration. However, California law prohibits the Nuisance Abatement Hearing Board from taking any action on any matter which is not on the posted agenda unless it is determined to be an emergency by the Board of Supervisors.

New agenda items will not be heard after 11:00 p.m. If agenda item is not fully discussed by 12:30 a.m., it will be continued at the discretion of the Chairman.
