Matters under the jurisdiction of the Nuisance Abatement Hearing Board and not on the posted agenda may be addressed by the general public following the completion of the regular agenda and any off-agenda matters before the Nuisance Abatement Hearing Board for consideration. However, California law prohibits the Nuisance Abatement Hearing Board from taking any action on any matter which is not on the posted agenda unless it is determined to be an emergency by the Board of Supervisors.

New agenda items will not be heard after 11:00 p.m. If agenda item is not fully discussed by 12:30 a.m., it will be continued at the discretion of the Chairman.
