Fink Road Landfill Solid Waste Facility Permit Revision

PUBLIC NOTICE IS HEREBY GIVEN in compliance with Title 27 of the California Code of Regulations, Section 21660.2 that the California Department of Resources Recycling and Recovery (CalRecycle), serving as the solid waste Enforcement Agency (EA) for Stanislaus County, will be conducting an informational meeting regarding a proposed Solid Waste Facility Permit revision for the Fink Road Landfill (SWIS No. 50-AA-0001) located at 4000 Fink Road, Crows Landing, California.

Purpose: The meeting is being held to provide information about a proposed revision to the Solid Waste Facility Permit for the Fink Road Landfill as requested by the Stanislaus County Department of Environmental Resources. The public will be offered the opportunity to comment and to ask the EA questions about the application package that was accepted for filing on January 24, 2020. If you would like to comment on this project, you may do so at the meeting, or you may send your written comments to the EA as provided above. The EA's preliminary determination is that the proposed changes require a permit revision. A summary of comments from the informational meeting and any written public comments received by the EA prior to the meeting will be included with the permit revision application package for consideration.

Project Description: The proposed permit revision reflects the following changes to the design and operation of the Fink Road Landfill: An increase in total design capacity from 14.64 million cubic yards to 28.29 million cubic yards by means of on-site infill and an increase in maximum elevation from 385 feet above mean sea level to 500 feet above mean sea level; an update in permitted disposal area; an update in maximum depth from 10 feet above highest groundwater to 5 feet above highest groundwater; addition of mattresses to the recycling activities; addition of cannabis waste to special handling; and minor updates to the Joint Technical Document. No increase in permitted acres, daily tonnage, or hours of operation are proposed.
