The Department of Environmental Resources strives to promote a safe and healthy environment and improve the quality of life in our community through a balance of science, education, partnerships and environmental regulation.

The department provides for State and local mandated education, investigation and inspection services in the following programs: Environmental Health; Hazardous Materials; Solid Waste Management; Landfill Operations; Code Enforcement; and Milk and Dairy. The Department has a budget of approximately \$21.3 million and a total of 80 full-time positions.

The department is a unique community organization dedicated to public health and environmental protection in Stanislaus County and the nine incorporated cities. This commitment to environmental protection is exemplified by the comprehensive programs provided.

DEPARTMENT OF PARKS AND RECREATION:

Mission Statement

The mission of the Department of Parks and Recreations to implement the policies established by the Board of Supervisors pertaining to parks, which includes acquiring, developing and maintaining recreation areas serving every segment of society, including the disabled and the economically disadvantaged; providing the leadership necessary to develop and manage parks and recreation facilities in ways that will provide the best possible experience for people to enjoy the out-of-doors at the most reasonable costs.

Stanislaus County Parks and Recreation is responsible for planning, developing, operating, and maintaining parks, reservoirs, County facilities, and service areas within the unincorporated areas of the County such as park basins, cemeteries, streetscapes, wildlife area, and landscape maintenance districts.

The park system covers 5 regional parks, 24 County facilities, 18 neighborhood parks, and 7 fishing access areas, 2 off-highway-vehicle parks, 4 cemeteries, 1 swimming pool, a wildlife area, which includes numerous County service areas, and cultural and historic facilities. The Department of Parks and Recreation employs approximately 20 full-time employees and 17 extra-help employees and a budget of \$5.3 million.
