IV. EEO Complaints

- County Complaints 7 investigated in our office since January 1 and 2 DFEH complaints. One submitted back to EEOC already.

V. Non-Standing Items

- Dale Butler EEO Award Nominations Ceremony scheduled for 10/17/12
 - One nomination received so far. Deadline is August 1. Reminders will be sent out between now and August 1. Recognition date could change if recipient or commissioners cannot be there. Good to get the date out there early.
- EEO Roles and Responsibilities (See handout) Kym oversees functions of EEO program. Collaborative team approach to program. Encouraged volunteers who may

- Diversity Week October 1-5, 2012
 - o International Festival is October 6th (always the first Saturday of October). CSA is the week prior as they begin planning the prior January.
 - Juneteenth 42nd year. Historic/commemorative freeing of slaves in 1865.
 Modesto has participated for the last 42 years. Third Saturday in June. Originally June 19th 2.5 years later than emancipation proclamation. GSA celebrates it with a potlock.
- Investigation Tracking Department complaint reporting process. Nancy and Kym explained new form in packet. CEO needs to track when an investigation occurs in departments. Form will be sent out each month for departments to update. Departments to send follow-up documentation to the CEO's office. Would like departments to provide feedback. It was shared that FMLA complaints have spiked. Disability/discrimination/retaliation issues have spiked. As an organization, want to focus on the big stuff but being bogged down with the small stuff. Any thoughts on reporting? It was decided that automating the documentation on the Intranet would not work due to confidentiality issues.
