Re: Parklawn United Neighbors v. Department of Finance, naming County entities as Real Parties in Interest

Dear Members of the Oversight Board, et al.:

California Rural Legal Assistance, Inc. (CRLA) represents clients who are directly affected by the 1991 Redevelopment Agency Settlement Agreement entered into between eight individuals, represented by CRLA, and the former Stanislaus County Redevelopment Agency.

The California Department of Finance (DOF) has determined, contrary to the determinations of the Successor Agency and the Oversight Board, that this 1991 Agreement is not an enforceable obligation under the Dissolution Act, and as such has not allowed the County to allocate tax revenue to the Successor Agency to perform the obligation. After sending a demand letter to the state, CRLA filed a petition and complaint for declaratory and injunctive relief against DOF challenging their erroneous determinations rejecting the 1991 Agreement as an enforceable obligation and demanding distribution of over \$10 million from the former Agency's Low and Moderate Income Housing Fund to other taxing entities.

CRLA and the County have worked together in the past to avoid potentially adversarial positions. For example, CRLA supported approval of the 1991 Agreement as an enforceable obligation on a series of ROPS. We also supported the Successor Agency and Oversight Board meet and confer efforts with the DOF. Because those efforts were unsuccessful, CRLA has filed this petition against DOF. We have not alleged claims against the Oversight Board, the Successor Agency, or the Auditor-Controller but have named each as a real party in interest solely because of the effect any judgment against the state may have on local entities.

We hope to preserve and increase funds for the County's affordable housing programs to the greatest extent possible, a goal we believe the County shares. Should you need an extension or more information, please let us know and we will be happy to accommodate.
