If you want a particular agenda item removed from "Consent", <u>please speak up and advise the Chair</u>. That item will then be withdrawn from "Consent" and reviewed in detail as scheduled. The remaining "Consent" items for which there are no voice objections will be handled by a single action of the Commission.

NON-CONSENT CALENDAR: These items will be individually discussed and reviewed in detail.

ANY MEMBER OF THE AUDIENCE DESIRING TO ADDRESS THE PLANNING COMMISSION REGARDING A MATTER ON THE AGENDA: While the Planning Commission welcomes and encourages participation in the Commission meetings, it would be appreciated if comments are limited to five minutes so that everyone may be heard.

PUBLIC COMMENT PERIODS: Matters under the jurisdiction of the Commission, and not on the posted agenda, may be addressed by the general public at the beginning of the regular agenda and any off-agenda matters before the Planning Commission for consideration. However, California law prohibits the Commission from taking any action on any matter which is not on the posted agenda unless it is determined to be an emergency by the Board of Supervisors. Any member of the public wishing to address the Commission during the "Citizen's Forum" period will be limited to a maximum of 5 minutes.

New agenda items will not be heard after 11:00 p.m. If agenda item is not fully discussed by 12:30 a.m., it will be continued at the discretion of the Chair.

*A. <u>USE PERMIT APPLICATION NO. 2008-23 - DENAIR COMMUNITY SERVICES</u>

<u>DISTRICT WATER TANK</u> - Request to construct a one million gallon water tank on a .23-acre parcel in the A-2-10 (General Agriculture) zoning district. The size of the on-ground tank is proposed at a 75 foot diameter and at a 35 foot height. The property is located on the west side of Lester Road, approximately 660 feet south of E. Zeering Road, adjacent to the Junior High School currently under construction, in the Denair Community. The Planning Commission will consider a Negative Declaration on this project.

*B. TIME EXTENSION FOR USE PERMIT NO. 2006-23 - UNITARIAN UNIVERSALIST CHURCH - Request for a one (1) year time extension to April 4, 2010 to obtain a building permit to activate Use Permit No. 2006-23 - Unitarian Universalist Church. The Use Permit was approved on October 4, 2007 to allow a new building of approximately 5,200 square feet for classrooms, meeting rooms, service areas and related parking to be used in conjunction with the existing church to the east. The project site is located on a 0.5 acre parcel in the A-2-10 (General Agriculture) zoning district at 2206 Kiernan Avenue in the north Modesto area. This project is exempt from CEQA.
