A. <u>USE PERMIT APPLICATION NO. 2007-10 – FOSTER FARMS DAIRY NO. 4</u>
<u>EXPANSION – Continued from December 19, 2013.</u> - Request to expand an existing dairy by adding four freestall barns, a maternity barn, a proposed rotary barn, and nine exercise pens so that the modified dairy would house a total of 3,520 cows (an increase of 2,690 cows from existing animals). The proposed expansion is on a 38-acre portion of two parcels totaling 610± acres in the A-2-40 (General Agriculture) zoning district. The remainder of the two parcels will be used to apply manure, process water, and grow forage crops. The property is located on the northeast corner of the S. Hickman and E. Keyes Roads intersection, south of Hickman, northeast of Denair. The Planning Commission will consider Certification of a Final EIR, including final CEQA Findings and Statement of Considerations.

B. REZONE APPLICATION NO. PLN2013-0092 – E & J GALLO WINERY Request to amend the zoning designation of 4.59± acres from R-2 (Medium Density Residential) to M (Industrial). If approved, the rezone would enable the applicant to construct parking lots in support of a new office building on the E & J Gallo Winery campus. The project site is located on various parcels on the west side of Santa Rita Avenue, south of Yosemite Boulevard (Highway 132) and north of Tenaya Drive, in the Modesto area. The Planning Commission will consider a CEQA Negative Declaration on this project.
