- A. <u>USE PERMIT APPLICATION NO. PLN2015-0087 ARTIFICIAL TURF & LANDSCAPING CO. Requesting continuance to April 7, 2016.</u> Request to establish a wholesale nursery and landscape contractor operation with 7-12 employees, on a 2.93± acre parcel in the A-2-40 (General Agriculture) zoning district. The project site is located at 1467 Crawford Road, north of Claribel Road, east of Coffee Road, west of Oakdale Road, in the Riverbank area. No structures are being proposed at this time, and the wholesale nursery will not be open to the general public. This is a request to establish a custom ripping and leveling agricultural services business, currently improved with a 10,000 square-foot shop, and a 1,000 square-foot office, and to allow for future expansion of an additional 10,000 square-foot shop and 1,000 square-foot office. Equipment is assembled, repaired and maintained on-site, and specialized parts are manufactured on-site as needed. The ripping and leveling activities occur off-site. The site is located at 3780 Ladd Road, on the southeast corner of Ladd and Stoddard Roads in the Salida area. The property is zoned Salida Community Plan Planned Industrial.
