## IX. REPORT OF THE PLANNING DIRECTOR

## **BOARD OF SUPERVISORS ACTIONS**

December 5, 2017: Approved the Planning Commission's Recommendation for Approval of Zoning Ordinance Amendment Application No. PLN2017-0119 — Commercial Cannabis Activities with the following amendments:

- Direct Staff to evaluate if artificial light cultivation when conducted within an existing building should be allowed in the A-2 (General Agriculture) zoning district and to return with a Zoning Ordinance amendment if determined that any of the existing registrant's will be impacted by the limitation in the ordinance as adopted.
- To review the list of registration applications for eligibility under the adopted Ordinances and to provide a report back to the Board of Supervisors. The report was provided to the Board of Supervisors on December 19, 2017.
- The Board of Supervisors approved the Planning Commission's recommendation to include parks in the definition of "youth centers", but did not include the recommendation to eliminate cannabis activities from the C-2 (General Commercial) zoning district or to increase the setback from residences from 200 to 600 feet or the elimination of the setback waiver or reduction provision. The Board of Supervisors added to the Regulatory Ordinance a provision requiring the decision making body, for the land use entitlement, to giving consideration to a Municipal Advisory Councils comments relating to cannabis activities within a MAC's boundary.

Approved the Planning Commission's Recommendation for Approval of Rezone Application No. PLN2017-0062 – Masellis

Enterprises, LLC.

Approved the Appeal of the Planning Commission Denial of Variance Application No. PLN2017-0064 – Hickman Market, thus approving the Variance, with an amendment to Condition of Approval No. 10 eliminating the need for the 8-foot masonry wall along the eastern property to be constructed within 10-years of Variance approval and instead only requiring construction of the wall until title to the project site or the adjoining parcel to the east (both owned by the applicant) is changed through sale or transfer.

December 19, 2017: Approved the 2018 Williamson Act Contract Applications.
