- В. SPECIFIC PLAN, GENERAL PLAN AMENDMENT, AND REZONE APPLICATION NO. PLN2013-0091 - CROWS LANDING INDUSTRIAL BUSINESS PARK - Request to adopt a Specific Plan allowing for the development of a 1.528 acre site to support a mix of aviation-compatible industrial and business park uses, general aviation, aviation-related land uses, public facilities, a multimodal (bicycle/pedestrian) transportation corridor, and supportive infrastructure. The project is anticipated to develop in three phases over 30-years with a 370 acre public-use airport and 14 million square feet of building space with the potential to generate 14,000-15,000 jobs. The project includes a request to establish a Specific Plan for the project, amend the General Plan designation of Agriculture to Specific Plan and rezone from A-2-40 (General Agriculture) to S-P (2) (Specific Plan). The project site is located in an unincorporated portion of western Stanislaus County, approximately 1.5 miles east of Interstate 5 (I-5), and 2.5 miles west of the community of Crows Landing. The 1,528-acre property is bounded by W. Marshall Road to the north, State Route (SR) 33 to the northeast, Bell Road to the east, Fink Road to the south, and Davis Road and agricultural land to the west. The Planning Commission will consider the Environmental Impact Report certified by Stanislaus County for the proposed project pursuant to the California Environmental Quality Act (SCH #2014102035).
