December 15, 2020: Approved the Planning Commission's recommendation of approval for General Plan Amendment and Rezone Application No. PLN2020-0016 - Brichetto - River Road, a request to amend the General Plan Designation of a 3.9± acre parcel and the zoning designation of two parcels totaling 7.8 acres in size to Planned Development to allow for the storage of recreational vehicles (RVs), located at 9919 Valley Home Road (SR 120) and 7420 River Road, between Rodden and Jackson Roads, north of the Stanislaus River, in the Oakdale area.

> Approved Use Permit and Development Agreement Application No. PLN2019-0095 - Central Valley Growers, LLC - Howard Road III, a request to establish a mixed-light commercial cannabis cultivation, nursery, processing, and distribution operation in phases on a 49 acre parcel in the A-2 (General Agriculture) zoning district, located at 3735 Howard Road, between the California Aqueduct and the Delta Mendota Canal, east of Interstate Highway 5, in the Westley area.
