- *C. TIME EXTENSION FOR VESTING TENTATIVE SUBDIVISION MAP APPLICATION NO. PLN2017-0013 GOLD STAR INVESTMENTS, LLC Request for a one-year time extension for VTSM Application No. PLN2017-0013 Gold Star Investments, LLC. The approved VTSM subdivided a 9.54± acres site into 28 residential lots, ranging in size from 5,100 square feet to 8,500 square feet and a 4± acre remainder lot in the Low-Density Residential Urban Services (R-1 US) zoning district.
