### 1. CALL TO ORDER AND INTRODUCTIONS

The meeting was called to order at 01:30 p.m. by Chief Probation Officer Mark Ferriera. Members of the group present in the meeting were identified.

### 2. PUBLIC COMMENT

No members of the public were present.

### 3. ADOPTION OF MINUTES FROM MAY 16, 2022, MEETING

MOTION: Sheriff Jeff Dirkse. SECOND: MPD Chief Brandon Gillespie. The minutes from May 16, 2022, meeting were approved.

### 4. BEHAVIORAL HEALTH AND RECOVERY SERVICES' COLLABORATIVE COURTS PRESENTATION

Behavioral Health and Recovery Services Director Tony Vartan advised the Community Corrections Partnership Executive Committee that today's presentation highlights BHRS's funding proposals and a design of Collaborative Courts that would streamline and speed up the process of individuals engaging in assessments and other behavioral health services treatments. The Collaborative Courts Division Proposal was presented by BHRS Manager Chandra Campbell (the presentation is attached to the minutes). The presentation included the following:

  - The request would be for 22.5 positions.
  - o \$2,965,992 for FY 2023-2024
  - o \$3,114,291 for FY 2024-2025
- CARE COURT SUPPORTIVE SERVICES REQUEST
  - o \$6,505,000 for FY 2023-2024
  - o \$6,830,250 for FY 2024-2025

Chief Gillespie of the Modesto Police Department asked what Behavioral Health and Recovery Services hopes to achieve with a Collaborative Courts Division. The Collaborative Courts Division, according to BHRS Director Tony

Vartan, is intended to provide an expedited court assessment and triage team to judicial partners, reduce the wait time on recommendations suited for the individual for court proceedings and treatment, and reduce jail capacity. Reed Wagner, Chief Deputy Public Defender, and District Attorney Jeff Laugero agreed that having a Collaborative Courts Division would greatly benefit all parties involved by providing an early assessment identifying the client's needs to move forward early in the process resulting in a decrease in caseloads and recidivism.

Chief Ferriera expressed concerns about the BHRS' funding proposals, using CCP revenue to fund CARE Court Supportive Services, a Governor's Program created to ensure success and not having any data to support the intended outcomes of the Collaborative Courts Division. Mr. Vartan stated that those who do not qualify for the Governor's Program would need to be referred, and the CARE Court Supportive Services funding request will be used to cover any overage costs. Additionally, Mr. Vartan stated that individuals who could benefit from the available programs are falling through the cracks and not being referred due to the lack of a program such as the Collaborative Courts Division. CPO Ferriera also addressed concerns about the capacity that the Collaborative Courts intends to serve, noting that the CCP-funded BHRS programs at the Day Reporting Center are currently not reaching the capacity of 75; Adult Drug Court has three clients in total, with one graduating on Friday, noting that it is the first graduation in years; and Mental Health Treatment Court may have one client. Sheriff Dirkse agreed with Chief Ferriera that CCP funds should not be used to fund a program that is already funded, such as CARE Court.

Ms. Campbell shared the program stats for the last fiscal year with the group. BHRS Fiscal Manager Tina Jamison reported that BHRS had cost savings to the CCP budget of \$900,000 in 2021 and \$1.3 million in 2022.

Traditionally the CCP Executive Committee goes before the Board of Supervisors once a year, as early as March and as late as July.


Chief Ferriera advised that the CCP Executive Committee will meet numerous times before it is time to go before the Board of Supervisors, noting he expects other funding proposals will be submitted. He suggested that voting on new funding requests be postponed pending reviewing and discussing the CCP Five-Year Spending Plan once all the requests have been received, except for the District Attorney's Office proposal, as it is time sensitive. Additionally, he advised the group that growth funding, following the Governor's proposed budget, has decreased significantly; but, the CCP budget was able to have some cost savings due to staff vacancies and CARE using grant funding.

The CCP Executive Committee discussed and agreed with CPO Ferriera's suggestion. Voting on any funding request, except for the District Attorney's Office proposal, will occur once all the requests have been received and the CCP budget has been reviewed.


The CCP Executive Committee postponed the last two items of this meeting's agenda for March 1<sup>st</sup>, 2023, at 10:00 am

Proposed Additions to the Adult System of Care






## Court Assessment and Triage Team











# Collaborative Courts Team Court Assessment/Triage Team

## Civil Proceedings


