I. CALL TO ORDER

The meeting was called to order at 12:10 p.m. by Chief Probation Officer Mike Hamasaki. Members of the group introduced themselves.

II. PUBLIC COMMENT PERIOD

No members of the public were present.

III. APPROVE APRIL 2018 MEETING MINUTES: JJCC

Motion: Cindy Duenas. Second: Melissa Marley. The minutes of the April 2018 meeting were approved unanimously.

IV. GIRLS ADVISORY COUNCIL

DPO Monica Manzo advised the proposed dates under consideration for the next Girls Advisory Council conference are March 15, 2019, March 22, 2019 and April 12, 2019. The venue will be Hanline Elementary School in Ceres and the Project Yes Campus has been offered. This conference is free of charge and all schools in Stanislaus County will be invited to attend. Speakers/breakout sessions proposed include a youth speaker on human trafficking, yoga, Project Yes speaker, Mental Health speaker, drugs, job core/MJC speaker, STI speaker and Hutton House/Pathways/Homelessness speaker. The conference time will be 9:30 a.m. to 1:00 p.m. Students will register for the conference through Eventbrite and the cap on the registration number will be 200. An app and website are being developed at a cost of \$1,600 a year for a professional package through the Project Yes program. The cost for the website will be \$8 - \$20 per year. A calendar will be available along with daily affirmations. The next Girls Advisory Council meeting is scheduled for December 12, 2018 at the Center for Human Services Conference Room from 3:30 p.m. to 4:30 p.m.

DPO Manzo reported that the 2017 Girls Advisory Council Conference had a total of 169 in attendance with 125 students. Ten high schools and two junior high schools sent students and two students attended from California State University – Stanislaus. Forty-four staff assisted with the conference and eleven agencies participated, including Center for Human Services, Stanislaus County Juvenile Probation, Haven House, Stanislaus County PAL, She Became, The Spot, Josie's Place, Project Yes, Aspiranet, and HARRT at Haven.

Division Director Dave Chapman reviewed that in 2016 the Girls Juvenile Justice Initiative Task Force proposed the idea to start a Girls Advisory County with partner agency participation to offer services to empower girls. The Young Women's Empowerment Conference in the Bay Area was used as a model for the development of the Girls Advisory Council. The first conference had more students, staff and agencies participating than anticipated. Schools bussed students to the conference. The next conference will offer break-out sessions and be prepared for more students to attend. Young men are invited to attend. The funding source is coming from the agencies involved. The Project Yes Campus is available and will be used for the next conference with timing structured to have more students able to attend. A Girls Advisory Council logo has been designed by a student. The age of participants is mostly junior high and high school students, ages 12 years and up. General population students are targeted and do not have to be involved in the juvenile justice system.

V. REVIEW JJCPA/YOBG PROGRAMS SUMMARY

Division Director Dave Chapman advised that at the JJCC meeting in April 2019 information will be presented to update Commission members on the programs supported by the Crime Prevention Act Grant. The programs funded by JJCPA include the following:

- Gender Responsive Alternatives to Detention (GRAD): Funding levels will continue for FY2018-19 which includes a contract for a Case Manager with the Center for Human Services.
- Juvenile High Risk Offender Unit: Funding levels will continue in FY2018-19. A proposal will be
 made to add a contract with County Workforce Development to provide employment development
 for both in-custody and out-of-custody youth. Sara Rudd from Workforce Development outlined
 the development and services provided by the "Let's Work" program. A more in-depth
 presentation on this program will be provided at the April 2019 meeting.
- Home Supervision Electronic Monitoring/House Arrest: Funding levels will continue for FY2018-
- Juvenile Drug Court: The partnership with Juvenile Justice Mental Health (JJMH) will be maintained for formal referrals for services and programs. The Probation Department is currently in discussion with community-based organizations to provide mental health counseling, substance abuse treatment, and anger management counseling for youth not served by JJMH or another service.

Programs funded by YOBG include:

- Home on Probation/JAIS assessment tool/Probation Supervision: Funding levels will continue in FY2018-19.
- Juvenile Commitment Facility: Funding levels will continue in FY2018-19. An increase has been
 made to the Children System of Care (CSOC) contract to allow for assessments required for level
 of care placement. The JJMH contract was increased for FY2018-19 to pay for required mental
 health assessment of youth who are being potentially placed in short-term residential treatment
 programs and group homes.
- IT/Research Staff: Funding levels will continue in FY2018-19 with the addition of two new
 positions which include a Senior Software Developer and Senior Systems Engineer. These
 positions were approved by the Board of Supervisors and have been added to the Probation
 Department.
- Juvenile Hall: Funding levels will continue in FY2018-19.
- Youth Assessment Center: This project is in the planning phase in FY2018-19. A contract has been executed with the Prison Law Office (PLO). The PLO will research models nationwide with site visits planned to San Mateo and Los Angeles Counties. BHRS will participate and preliminary discussions have been held with Modesto Police Department, CSA, and Health Services Agency. The assessment center will be utilized in the front-end of the system before they become involved in the juvenile justice or youth welfare system. An update will be presented at the April 2019 meeting. The implementation phase for a pilot program is proposed for FY2019-2020.

VI. SET DATE AND TIME OF NEXT MEETING

The next meeting is tentatively scheduled for Thursday, April 11, 2019 at Noon at the Probation Department.
