- Traffic Forecasting Model Calibration/Validation report has been submitted to Caltrans. Existing Conditions Operations Report has been approved by Caltrans.
- Environmental Update: Alternative screening methodologies report was reviewed. There were 17 alternatives that were identified from the scoping meetings. The alternatives were individually reviewed. Next month, we will have three or four alternatives left for consideration.
- A second Section 6002 meeting was held on January 19, 2011 for participating or cooperating agencies: California Fish & Game, San Francisco Public Utilities Commission (SFPUC), United States Fish & Wildlife Service (USFWS), Army Corps, and local agency representatives.
- Approximately 70% of the Permission to Enter (PTE) letters have been returned. Follow up letters were sent to the remaining residents/property owners (approximately 300) via certified mail on January 9, 2011.
