# 1. CALL TO ORDER

## 2. APPROVAL OF MINUTES FROM January 28, 2012 MEETINGS

## 3. AGENDA ITEMS

- a. **<u>Project Updates (INFORMATION ONLY)</u>** 
  - Kris Balaji provided the updates.
  - There was a Community Focus Group (CFG) meeting on February 29<sup>th</sup> in Riverbank. Another meeting is scheduled for June 13<sup>th</sup>.
  - Traffic Update The traffic study has been submitted to local agencies for their review, and then will be sent to Caltrans.
  - Environmental Update –Completed the paleontology study. In the process of compiling surveys. Completed the March and April surveys for California Tiger Salamander.
  - Design Update Geometric review comments received from Caltrans have been addressed. Preliminary geotechnical field work has been completed.
- b. <u>Amendment #4 to the Agreement for Professional Design Services with Jacobs</u> <u>Engineering Group, Inc. (MOTION)</u>
  - Matt Machado gave an overview. The purpose of Amendment #4 is to cover needed charges of scope in environmental studies and traffic analysis. The environmental scope changes will include protocol surveys for California Tiger Salamander (CTS) Surveys, Branchiopod Surveys, and Botanical Surveys. The traffic scope change will include traffic analysis for a hybrid alternative.
  - The motion was approved to approve the Authority Manager to execute Amendment #4 to the Agreement for Professional Design Services with Jacobs Engineering

Group, Inc for the North County Corridor Transportation Expressway Project for a total contract amount not to exceed \$9,399,222. This amount shall include, without limitation, the cost of any subcontractors, consultants, experts or investigators retained pursuant to Professional Design Service Agreement. On Motion of Terry Withrow / Seconded by Virginia Madueño. All in favor -4/0.

### 4. AUTHORITY MANAGER'S REPORT

• California Transportation Commission took action a month ago on the rescission of the old bypass right-of-way (to sell), which will bring in more funds. Caltrans has been very instrumental in this action.
